## 2018 National Conference

Plans are underway for the 2018 (81st) National Conference to be held in Cleveland, OH March 19 - 23, 2018. The theme of the 2018 National Conference is “**Modern Technology, Police Training & Equipment**” (AM) and “**Police Accountability & Community Involvement**” (PM). The Conference will be held at the Embassy Suites by Hilton Cleveland Rockside.

The Hotel is less than 12 miles from the Hopkins International Airport and 8 miles to downtown Cleveland. The Hotel offers a complimentary shuttle to/from the airport and offers FREE Hotel parking.

Every room is a two-room suite. The Hotel has a fitness center, whirlpool, billiards tables and an indoor swimming pool. **The Hotel is a 100% Non-Smoking Facility.**

The Hotel offers on-site dining at the Embassy Grille Restaurant. The Hotel also offers a FREE made-to-order breakfast for Hotel guests. The Hotel has other surrounding restaurants including the Bonefish Grill, Delmonico's Steakhouse, and McDonalds.

The room rate (single through quad) is **\$120.00/night (price includes tax)**. **Room reservations must be made by February 15, 2018** to avoid higher rates. To make reservations, please use the ONLINE link on our web site at [www.acjalae.org](http://www.acjalae.org).

The **Pre-registration Form** is available on our web site along with “**Things You Need To Know**” about the upcoming Conference. The pre-registration fee for members is \$180; for guests, \$150 (**prepaid and post-marked by February 23, 2018**). Late and on-site registration for members is \$230; guests \$200 (after February 23rd).

The **Firearms Competition** will be held at **Stonewall Limited Gun Shop**, an indoor range which is 10 minutes from the Hotel. Shooters **will not** be charged a range fee and can bring their own ammunition or buy ammunition at the range. To participate in the Firearms Competition, members **MUST** sign a Statement of Competency that they have achieved a minimum score of 240 on the ACJA-LAE course of fire.

The **Physical Agility Competition** will be held next to the firearms range. All participants **MUST** attend the Safety Meeting on Tuesday morning (March 20th) to sign waivers. (This meeting is mandatory! You will not be allowed to compete in the Firearms or Physical Agility competitions if you do not attend the Safety Meeting.)

The **Written Competitions** will be 75 multiple-choice questions. The 27th Annual Lip Sync / Talent Contest will be held on Wednesday, March 21st.

Additional training will be offered on Thursday for professionals and non-professionals. Some of the attractions in Cleveland is the Rock and Roll Hall of Fame, NFL Hall of Fame, Cleveland Museum of Natural History, and the Cleveland Metroparks Zoo.

Region 6 is working hard to bring you five days of workshops, competitive events, guest speakers, and entertainment. Plan now to attend! ## Filing the E-Postcard

**Chapters:** Do not forget to file the e-Postcard for your chapter by May 15, 2018. The e-Postcard has to be filed electronically (there is a direct link on our web site). Chapters should use the tax period of January 1st through December 31st of each year. The e-Postcard takes less than 5 minutes to complete. If your chapter has their Federal tax exempt status revoked because of failure to file the e-Postcard, the chapter cannot ask for non-profit tax donations and will have to pay Federal tax on any revenue received during the reporting year.

Furthermore, the chapter will have to reapply for tax-exempt status by filling out the appropriate IRS forms and paying the appropriate User Fee to have their tax exempt status reinstated. It could take up to a year or more to get the chapter reinstated as a non-profit.

## Key Awards

As a member of ACJA/LAE, you are entitled to receive our **Scholastic Honor Awards**. In recognition of outstanding scholastic attainment in the field of the administration of criminal justice, Keys (a distinctive charm/pin with the ACJA/LAE logo) and a Certificate are awarded to members who exemplify themselves academically. Members who qualify can obtain their awards by submitting a Certified Grade transcript along with the **Scholastic Honor Awards Form** (available on our web site). Upon verification that the candidate meets the requirements for the Award, the Certificate and Key Emblem will be mailed to the recipient. The qualifications are as follows:

**Graduate Keys**—are awarded to those members who meet the requirements with a Graduate/Masters Degree. In order to qualify for a Graduate Key, a member's GPA average must be at least 3.5 on a scale of 4.0.

**Gold Keys**—are awarded to those members who meet the requirements with a Bachelors Degree. In order to qualify for a Gold Key, a member's GPA average must be at least 3.5 on a scale of 4.0.

**Silver Keys**—are awarded to those members who meet the requirements with an Associate Degree. In order to qualify for a Silver Key, a member's GPA average must be at least 3.5 on a scale of 4.0.
